**This contract covers Boarding, Dog Day Camp and Grooming**

We have provided our Beaston Camp Kennels/POSH contract so that you may further understand what is required of you and your dog before enrolling in any of our services.

You will be asked to read and sign this contract at the time of your dog's acceptance into our facilities.

This is a contract between Beaston Camp Kennels and, \_\_\_\_\_, The

I, \_\_\_\_\_ (owner), hereby certify that my dog(s)  
\_\_\_\_\_ is/are in good health and  
have not been ill with any communicable condition in the last 30 days. I further certify that my dog(s)  
have not harmed or shown any aggressive or threatening behavior towards any person or any other dog.  
Beaston Camp Kennels agrees to exercise due and reasonable care in the handling of dogs, and in  
keeping the facility properly enclosed and sanitary. All dogs are cared for by Beaston Camp Kennels  
without liability on Beaston Camp Kennels behalf for loss or damage from disease, theft, fire, death,  
escape, injury, or harm to persons, other dogs, or property by said dog(s), or for other unavoidable  
causes.

**I HAVE READ AND UNDERSTAND THE FOLLOWING:**

1. I understand that I am solely responsible for any harm caused by my dog(s) while my dog(s) is/are in the care of Beaston Camp Kennels and release Beaston Camp Kennels of any liability arising from my dog's attendance and participation at the day camp, grooming or boarding.
2. I recognize that there are inherent risks of illness or injury when animals are allowed to be in close contact with one another. Such risks include, but are not limited to, problems resulting from rough play and canine cough (doggie colds).

3. I further understand and agree that in admitting my dog(s) to Beaston Camp Kennels, the staff have relied on my representation that my dog(s) is/are in good health and have not harmed or show aggressive or threatening behavior towards any person or any other dog.

4. I understand that my dog(s) will be playing in open areas with other dog(s) and accept that when dogs play in groups, they will get dirty, and nicks and scratches may occur, as well as any other inherent risks that are involved and I hereby release Beaston Camp Kennels of any liability; I further understand and agree that Beaston Camp Kennels staff will not be liable for any or all problems which may develop.

5. I further understand and agree that any problems which develop with my dog(s) will be treated as deemed by Beaston Camp Kennels staff, at their sole discretion, and that I assume full financial responsibility for any and all expenses involved if I or Beaston Camp Kennels decides to obtain medical treatment.

6. I accept that if my dog causes any excessive damage to the facility that I could be asked to pay for repairs.

7. I understand that if my dog is not spayed or neutered by 7 months of age, they will not be allowed to participate in day camp with other dogs, or they will have to stay home.

8. I further understand that if my dog shows any signs of aggression towards other dogs, that their acceptance into day camp will be reevaluated.

They will be given between 1 and 3 chances, depending on the situation surrounding the aggression before they are forbidden to participate in day camp.

9. Human aggressive dogs, or dogs with fear issues, will not be allowed to stay at any Beaston Camp Kennels resort.

10. As a responsible pet owner, I promise to keep my pet(s) up-to-date on all vaccines, including bordetella and rabies, and all other state required vaccines. It is required by Beaston Camp Kennels that you provide official updated records from a veterinarian before you are allowed to board, groom or attend day camp.

Beaston Camp Kennels is not responsible for informing of due dates on vaccines nor will Beaston Camp Kennels provide vaccine records for any reason. Furthermore, when pet(s) vaccines are updated, a copy must be provided to Beaston Camp Kennels in order for our records to stay updated, otherwise Beaston Camp Kennels will assume that your pet(s) are not current on vaccines and will be asked not to attend day camp until 72 hours after actual vaccines are administered.

FEES:

DAYS AND HOURS: Monday through Sunday - Drop off after 7am – Day camp is from 8am – 4pm. Staff goes off duty at 6:00 pm and any dog not picked up will be put in boarding at the current rates

EMERGENCY: In the event of an emergency, Beaston Camp Kennels staff will first attempt to contact the owner, followed by an attempt to contact the emergency contact person listed. Beaston Camp Kennels may also directly contact the veterinarian listed, or any emergency veterinarian of Beaston Camp Kennels choice, if the circumstances are deemed such that immediate treatment is necessary. Beaston Camp Kennels staff retains sole discretion in emergency matters, without liability, and the owner of the dog agrees to promptly pay for all medical treatments received. Owner agrees to pay for reasonable attorney's fees incurred by this boarding facility in the collection of any boarding, grooming daycare or other charges incurred by the owner of the above animal(s).

Grooming Specific:

1. The animal is fit and healthy. Any grooming which takes place on an elderly animal or animal with health problems will be at the owner's risk. Grooming may expose pre-existing health/skin problems for which the kennel cannot be held liable.
2. De-matting/thinning/shaving of matted hair may cause patchiness and hair loss. Consent to remove the matted hair is on this understanding.
3. Payment will be made as per price list/quote and owners must collect pets at time stated. Uncollected pets will be charged current boarding rates.
4. This contract is binding for the current groom date and any future groom dates. Prices and fees are subject to change without notice.

I certify that I have read and understand the policies of Beaston Camp Kennels as set forth on the preceding pages. I have read and understand the conditions and statement of this agreement.

I acknowledge and accept that all the above policies refer to day camp, as well as overnight stays, and grooming and this release serves as accepting these conditions for all three services.
